2024-2033 Draft STIP **UPDATE!**

NCDOT recently released an update to the Draft 2024-2033 State Transportation Improvement Program (STIP.) A part of the State budget included a transfer of State sales tax revenues to NCDOT, improving the financial forecast for the STIP over the next ten years and enabling the addition of more projects that were initially shown as decommitted or cut in the first draft of the 2024-2033 STIP.

The additional projects in the French Broad River MPO planning area include:

Buncombe County

- U-5832 Modernization of NC 81 (Swannanoa River Road) from Biltmore Avenue to US 74A (South Tunnel Road)
- U-2801A Widening of US 25A (Sweeten Creek Road) from US 25/NC 280 to Rock Hill Road
- A-0010AA Widening and Modernization of Future I-26 from **Broadway to Weaver Boulevard**

Haywood County

- U-4712 Widening of South Main Street from US 276 to Hyatt Creek
- U-6158 Intersection Improvements to US 276/Crymes Cove Road/Raccoon Road
- U-6159 Access Management to US 276 (Russ Avenue) from US 23/74 to US 19 (Dellwood Road)
- U-6048 US 19/23 Modernization from Chestnut Mountain Road to Wiggins Road (partially in Buncombe County

Reconnecting **Communities Grant**

The Reconnecting Communities Grant is a Federal program dedicated to reconnecting communities that were previously cut off from economic opportunities by transportation infrastructure. Funding supports planning grants and capital construction grants, as well as technical assistance, to restore community connectivity through the removal, retrofit, mitigation, or replacement of eligible transportation infrastructure facilities. \$1 billion in discretionary funding will be available over the next 5 years through IIJA. Clean Transportation Plan

Governer Cooper signed E.O. 246 in January 2022, titled "North Carolina's Transformation to a Clean, Equitable Economy" with the goal of reducing economy-wide greenhouse gas emissions in North Carolina. EO 246 outlines two new goals for the state:

- 1. Reduce economy-wide greenhouse gas emissions to at least 50% below 2005 levels by 2030 and achieve net-zero emissions no later than 2050
- 2. Increase the total number of registered, zeroemission vehicles (ZEVs) to at least 1,250,000 by 2030 and increase the sale of ZEVs so that 50% of in-state sales of new vehicles are zero-emission bv 2030

NCDOT is tasked with creathing the Clean Transportation Plan within 15 months of the order. The team is working to make a significant, equitable investment and plan into NC's clean transportation future. Planner for Land of Sky Regional Council, serving as the Zoning Administrator for the Town of Montreat.



As always, our trusty Eco-Counter is used on greenways and downtown areas for weeklong periods to gauge usage on these pathways. This count was done at Bill Moore Community Park in Fletcher. This count was completed in early August during a sunny and warm week! With around 8,700 users, this was our largest count of the summer!
