**WHEREAS**, the French Broad River Metropolitan Planning Organization (FBRMPO) Board is the duly recognized transportation decision-making body for the continuous, cooperative, and comprehensive transportation planning process of the FBRMPO Planning Area; and

**WHEREAS**, the 2026-2035 Transportation Improvement Program is in agreement with the 2050 Metropolitan Transportation Plan (MTP) in accordance with 23 CFR Part 134; and


**WHEREAS**, the programs and projects included in the 2026-2035 Transportation Improvement Program are financially constrained in accordance with State and Federal law; and

**WHEREAS**, the 2026-2035 Transportation Improvement Program has been developed in accordance with North Carolina's Strategic Transportation Investments Act and is in agreement with the North Carolina 2026-2035 State Transportation Improvement Program; and

**WHEREAS**, the French Broad River MPO provided for public comment beyond the minimum required by the French Broad River MPO Public Involvement policy; and


**NOW THEREFORE, BE IT RESOLVED** that the Board of the French Broad River Metropolitan Planning Organization adopts the 2026-2035 Transportation Improvement Program.

## About the Transportation Improvement Program

French Broad River Metropolitan Planning Organization, established in 1962, serves as the federally designated Metropolitan Planning Organization (MPO) for the four-county Asheville metropolitan region in western North Carolina. FBRMPO coordinates regional transportation planning and funding for over 414,000 people across 21 municipalities within Buncombe, Haywood, Henderson and Madison counties.

The Transportation Improvement Program (TIP) is a federally mandated document MPOs are required to produce that reflects the planned investments in a region's transportation infrastructure over at least four years. The TIP was developed to meet all federal requirements in coordination with the North Carolina Department of Transportation (NCDOT), in addition to other local, state and federal transportation planning partners.

The TIP shows all multimodal projects that are using state or federal transportation funds in the MPO Planning Area as well as some projects that are locally funded or have a local government cost-share component. This includes some of the major interstate widenings in the region, other roadway widenings, roadway re-configurations, intersection improvements, public transportation projects, bicycle and pedestrian projects, and aviation projects.

According to federal and state law, TIPs must be "financially constrained." Pages 5-6 of the TIP document demonstrate the fiscal constraint of the TIP by showing how the various federal and state funding sources are distributed through the region. This financial guidance also helps establish highway and transit funding levels that may be reasonably anticipated by the MPO over the TIP period from appropriate federal and state resources.

The TIP shows estimated costs and schedules by project phase. It not only lists specific projects but also documents the schedule and cost for each project phase (preliminary engineering, final design, right-of-way acquisition, and construction). It is important to note that the TIP is a planning document that does not show anticipated cross-sections or other design details of projects. Because the TIP is not a final schedule of project implementation, it may be changed after it is adopted through amendments as outlined in French Broad River MPOs Public Involvement Policy.

While many of the projects shown in the TIP show individual, specific project locations, some do not. Some projects show that there will be resurfacing, safety, or other types of projects within the planning area. For those projects, NCDOT has other websites and resources that show more specifics about the planned resurfacing projects or safety projects. Many of these projects are not expected to result in major changes to the roadway but may include the addition of shoulders, guardrails or other components to help improve some operational elements of the transportation system.

It should also be noted that many projects listed as "roadway" projects may include bicycle and pedestrian components as those projects are developed, based on the NCDOT Complete Streets Policy. For more information on bicycle and pedestrian improvements that may be included as part of some of the projects listed in the TIP, please contact MPO or NCDOT staff.

In order to maintain consistency between the TIP and STIP, as federally mandated, a set of TIP Modification and Amendment Policies have been developed to govern the TIP and its associated projects. As Modifications and Amendments are made to the TIP, they will be attached to the TIP document in the Appendices and the Date Modified on the cover page will be updated to reflect the changes.

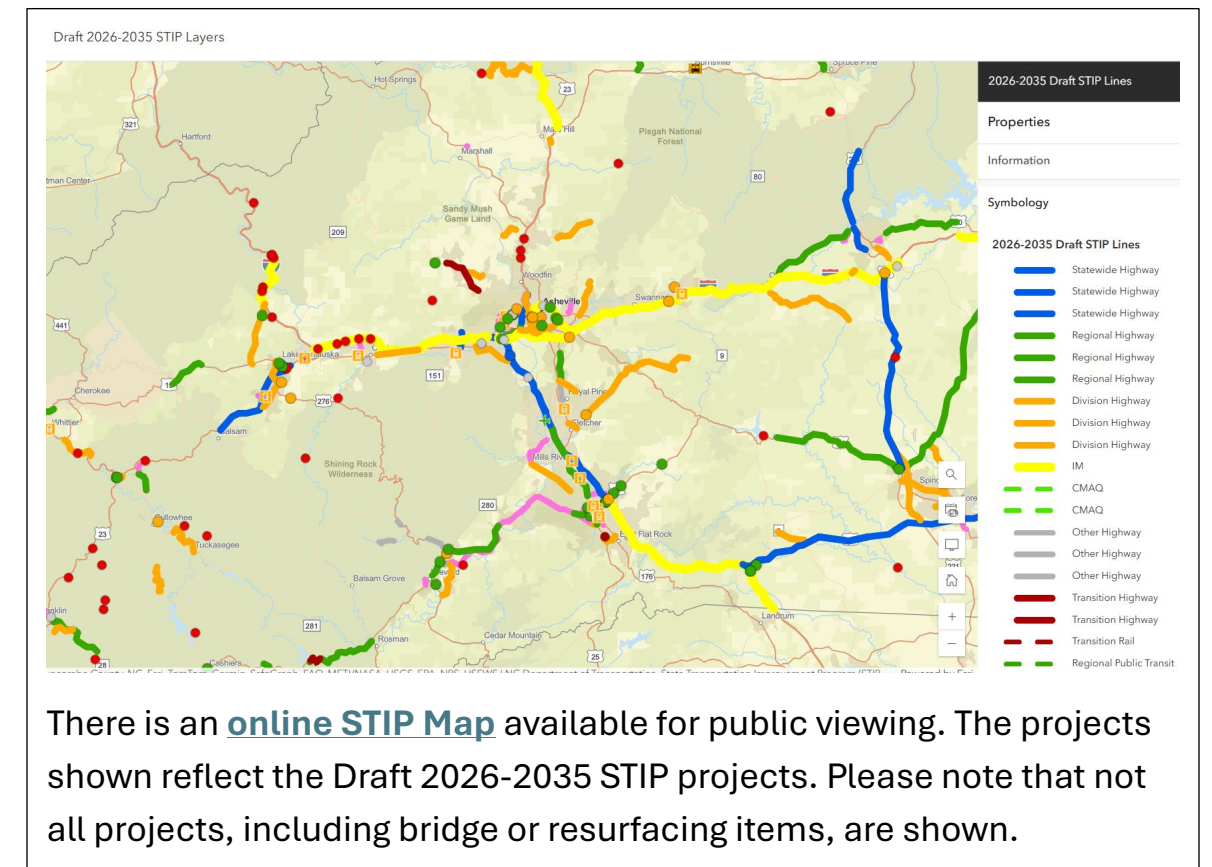
## Development of the Transportation Improvement Program

The development of the TIP is structured through North Carolina's Strategic Transportation Investments Act (STI), passed by Governor Pat McCrory and the NC Legislature in 2013. STI mandates a performance-driven process that is transparent and data driven. The prioritization process that results in the projects that make up the TIP is a relatively complex process that involves choosing transportation projects from long-range plans, data-driven assessments and scoring by the NCDOT Prioritization Office, and the application of local-input points by MPOs, RPOs, and NCDOT Divisions. The development of the 2026-2035 TIP took place between 2022 and 2024 with coordination between NCDOT, NCDOT Divisions, the French Broad River MPO, and the local governments throughout the MPO region. In the summer of 2023, the FBRMPO coordinated with counties and local governments to prioritize and submit projects through the Prioritization process (P7). Throughout the prioritization process, MPO staff solicited input from the public either through advertisements soliciting general comments or surveys distributed throughout the region as outlined in French Broad River MPOs Public Involvement Policy. Due to rising costs for projects funded in the previously adopted 2024-2023 TIP, little was projected to be available for new projects in the statewide mobility tier of the 2026-2035 TIP and negative funding were projected in the regional impact and division needs funding tiers. When the draft 2026-2035 STIP was released in January of 2025, the French Broad River had many previously committed and unfunded projects cut from the STIP totaling around \$1 billion.

The NCDOT Board of Transportation has demonstrated fiscal constraint on the 2026 - 2035 STIP to be adopted on 7/9/2025. The French Broad River MPO TIP is a subset of the STIP and by extension therefore demonstrates fiscal constraint.

The following two pages reflect the fiscal constraint summaries for highway and non-highway programs. The fiscal constraint and funding summary provides a summation of the various federal, state, and local funds to be used for the first four years of the TIP (2026 - 2029).

## **2026-2035 STIP Performance Measures**

The French Broad River Metropolitan Planning Organization (FBRMPO) has established performance management targets for highway safety (established in the Strategic Highway Safety Plan (SHSP)), transit tier 2 providers that choose to participate in NCDOT's Group Transit Asset Management (TAM) Plan, and performance management targets for infrastructure condition, congestion, system reliability, emissions, and freight movement. The FBRMPO anticipates meeting their identified targets with the State funded Highway Maintenance Improvement Program (HMIP) and the mix of projects included in the STIP aided by the Strategic Transportation Investments Prioritization and Programming process. The HMIP is a State funded program of projects that are programmed outside of the STIP. The FBRMPO collects data and other information at regular time intervals from the transit agencies relative to measure and assess progress toward meeting performance targets.

In North Carolina, pavement and bridge performance is primarily impacted through state funded programs that are managed outside the STIP. The Department's HMIP, identifies planned maintenance activities for a five-year time period, which include pavement, bridge, and other general maintenance projects across our entire roadway network. The amount of funding provided through these state funded programs is roughly equivalent to the amount of state and federal funding programmed in the STIP over the same period. In relation to NHM specific routes, the STIP does include some specific federal funding for interstate pavement and bridge maintenance through our own internal interstate maintenance program. Federal funding for bridges included in the STIP is applied primarily to non-NHS bridges. While the STIP can have an impact on the condition of our NHS pavements and bridges, specifically on the interstate system, the majority of the funding impacting the condition of our pavements and bridges is managed outside the STIP.

Public transit projects in the STIP align with the transit safety planning and target setting process undertaken by the transit agencies and MPOs. While the North Carolina DOT aided with the development of a template for the initial Public Transportation Agency Safety Plans (PTASPs), each large urban transit provider is responsible for implementing its PTASP, which includes transit safety targets. Investments are made in alignment with PTASPs with the intent of keeping the state's public transit operations, vehicles, and facilities safe and meeting transit safety targets. State and federal funding sources that can be used by transit agencies for operations, vehicles, and facility improvements are outlined in the Public Transportation Project Funding section of the NCDOT 2026-2035 Current STIP. Individual transit agencies determine the use of these sources for capital and operating expenses based on their local needs.
